Introduction

Maryland is one the wealthiest states in the nation based on per capita income, but not all Marylanders share in the prosperity. In Maryland, 880,000 residents are participants in the Supplemental Nutrition Assistance Program (SNAP). Households that experience prolonged food insecurity are at the greatest risk of experiencing hunger. The USDA defines food insecurity as an economic or social condition of limited or uncertain access to adequate quality and quantity of food[1]. "Very Low" food security means that children go to sleep hungry and go to school with unfilled stomachs. To cope, families make difficult decisions — parents, grandparents, and other caregivers may skip meals so that they can feed their children, eat less to stretch out a meal, or purchase foods that are filling but lack vital nutrients. Many working adults face high costs of living and inadequate wages and struggle to earn enough money to put nutritious meals on the table, pay bills, and afford transportation. Older adults and people with disabilities on fixed incomes are often forced to choose between food and medicine. This is true in every county in Maryland.

Since 2007, Maryland Hunger Solutions has remained committed to promoting and advocating for long-term and sustainable solutions to eliminate hunger for all of Maryland's residents. The organization works with state and community partners to provide education about the stark reality of hunger's existence in Maryland and the proven solutions to reduce food insecurity, improve public policies to end food insecurity and poverty, and ensure that all eligible residents are connected to federal and state nutrition programs, proven tools to reduce hunger and poverty. A core strategy of Maryland Hunger Solutions has been to increase and expand participation in the federal nutrition programs, especially the Supplemental Nutrition Assistance Program, which serves as the state's first line of defense against hunger. Another priority has been promoting maternal and early childhood nutrition programs, school meals programs, and out-of-school time programs (such as afterschool and summer meals) that ensure children of all ages get the nutrition they need for their development. Maryland Hunger Solutions has connected local, state, and national anti-hunger advocates, government agencies; medical professionals; service providers and other nonprofits; and food policy councils to make progress toward ending hunger in Maryland. Since the onset of the pandemic, Maryland Hunger Solutions has redoubled our efforts to ensure all Maryland residents have access to healthy and nutritious food.

The Maryland Hunger Profiles provide accurate local data on federal nutrition program participation, population, and poverty data for each of the 24 jurisdictions. Behind the percentages outlined in the Maryland Hunger Profiles are the tens of thousands of children, older adults, people living with disabilities, veterans, and low-wage earners who would not get the daily nutrition they need to be productive without these programs. Still, many nutrition programs have not yet realized their full capacity of service for thousands of Marylanders. The purpose of these data profiles is to allow policymakers, partners, and the public to understand the state of hunger within Maryland and inform ongoing community and policy conversations about ensuring Marylanders have sufficient nutrition and the opportunity to thrive. This is especially true as we continue to navigate the COVID-19 pandemic and recover from the economic and health fallout. Everyone is a stakeholder in the fight against hunger, and together, we can create a hunger-free Maryland.

Definition of Terms

Calendar Year (CY): The calendar year begins on January 1st and ends on December 31st. CY 2022 began on January 1, 2022, and will end on December 31, 2022.

The following data derives from CY 2021 due to the data available at the time of its creation. This document was created at the end of 2021 and finished during the first week of January 2022.

State Fiscal Year (SFY): The fiscal year in Maryland begins on July 1st and ends on June 30th. SFY 2020 started on July 1st, 2019, and ended on June 30th, 2020 [2].

The following report section is based on SFY data: WIC data.

School Year (SY): For the purposes of this report, SY data covers the months of September-May. The following report section is based on SY data: Child Nutrition data, Community Eligibility Provision data.

Food Insecurity: Is defined by the USDA as a household-level economic and social condition of limited or uncertain access to adequate food. Prolonged food insecurity results in the physiological experience of hunger. Food insecurity is measured by the level of food security: Very Low, Low, Marginal, and High. Measurement of food insecurity is generally obtained by self-reported survey and indicates a household's level of anxiety over having enough food to eat, the change in diet and quality of food consumed, and the number of times eating patterns have been disrupted [3].

Poverty Guidelines: Annual federal poverty levels (FPL) are issued by the Department of Health and Human Services. Federal nutrition programs use the guidelines (or a percentage of the guidelines, such as 185 percent of the FPL), in determining income eligibility. The FPL varies by household size and, unlike the Census Bureau (statistical) poverty thresholds, has no age distinction. In 2022, the FPL was \$13,590 for an individual and \$27,750 for a family of four [4].

Identified Student Percentage (ISP): This number captures the percentage of enrolled students who are "categorically eligible" (automatically eligible) for free school meals and can be directly certified by the school system without submitting a school meal application. In Maryland, this includes children in households participating in the Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), or the Food Distribution Program on Indian Reservations (FDPIR), as well as children in foster care, migrant, homeless, or runaway youth, and Head Start. Beginning in the 2022-2023 school year, this also includes children participating in Medicaid.

Community Eligibility Provision (CEP): The Community Eligibility Provision allows high poverty schools to offer free breakfast and lunch to all students without having to collect, process, or verify school meal applications. Any district, group of schools in a district, or individual school can choose to participate if they have an Identified Student Percentage (ISP) of 40 percent or higher. Schools that adopt CEP are reimbursed based on the ISP, which is multiplied by 1.6 to determine the percentage of meals that will be reimbursed at the highest rate.

Description of Programs

Child and Adult Care Food Program (CACFP): The CACFP provides healthy meals and snacks to eligible children and adults in child and adult care centers, afterschool care programs, and day care homes. Children living in emergency shelters, adults with disabilities that are enrolled in day care facilities, and adults aged 60 and above, are also eligible to receive meals through the CACFP.

This report depicts CACFP data of meals and snacks served by public school authorities through the At-Risk Afterschool Meals Program only.

National School Lunch Program (NSLP) and School Breakfast Program (SBP): The NSLP and SBP provide per meal cash reimbursements to schools as an entitlement to provide nutritious meals to children. Students living in households with an income at or below 130% of the federal poverty level are eligible to receive free school meals and students with a household income of 185% of the federal poverty level or below can qualify for reduced-price school meals.

Summer Food Service Program (SFSP): The SFSP provides free meals to kids and teens ages 18 and under in low-income areas to ensure that children continue to receive meals when school is not in session. Local governments, school districts, and private nonprofits can sponsor summer meal sites, which may be located at schools, parks, community and faith centers, local libraries, recreation centers, housing complexes, and other neighborhood locations. Sponsors are reimbursed for each eligible meal and snack served through the administering state agency. Summer meal sites can either operate as "open" or "closed-enrolled" sites. An "open" site serves meals to all children in the community and must be located in an area where at least 50 percent of the children are eligible for free or reduced-price school meals. At a "closed-enrolled" site, only children enrolled can participate. The site qualifies if it is located in a low-income area or if 50 percent or more of the children enrolled in the program are eligible for free or reduced-price school meals.

In response to the COVID-19 pandemic, USDA issued temporary nationwide waivers that allowed summer meal programs to operate year-round and with increased flexibilities in order to ensure students continued to have access to healthy meals during school closures.

This report depicts SFSP data of meals served by public school authorities only. Meals served by non-public school sponsors such as faith-based organizations, government agencies, private schools, and non-profits are not included.

Seamless Summer Option (SSO): Public and private nonprofit school sponsors may opt to use the Seamless Summer Option, which operates under the same rules as SFSP, but provides a slightly lower free reimbursement rate for all meals served.

In Maryland, all school meals served during the 2021-2022 school year were served through the SSO.

Description of Programs

Supplemental Nutrition Assistance Program (SNAP): SNAP provides monetary (EBT) benefits to supplement the food budget of limited resource families so they can purchase healthy food and move towards self-sufficiency. To get SNAP benefits, you must apply in the state in which you currently live and you must meet certain requirements, including resource and income limits, work rules, and citizenship or qualified immigrant Status. There are special SNAP rules for households with elderly or disabled members.

Special Supplemental Nutrition Program for Women, Infants, and Children (WIC): The WIC Program serves women who are pregnant, postpartum, and breastfeeding, infants up to one-years-old and children up to five years old. Participants must meet categorical, residential, income and nutrition

and children up to five years old. Participants must meet categorical, residential, income and nutrition risk requirements. The state agency's income eligibility standard must be between 100 percent and 185 percent of the federal poverty income guidelines. Applicants can be determined income-eligible for WIC based on their participation in or eligibility for other specific income-based programs.



2022: A Reflection on the Coronavirus Prevailing Pandemic Adaptations

In March of 2020, to minimize the spread of COVID-19, schools and businesses nationwide closed. This resulted in a sudden increase in unemployment. The closures had a devastating effect on individuals, families, and the economy within the state of Maryland. In one month alone, Maryland Hunger Solutions received over 3,000 calls to our toll-free number, SNAP (Maryland's Food Supplement Program) application hotline from affected people searching for assistance. Many were first-time applicants. In Maryland, there was a 400% increase in the number of SNAP applications received in April of 2020, as compared to March 2020 — nearly 150,000 applications (5). Every county in the state witnessed a surge in need, with Baltimore City seeing increases in SNAP applications of over 600% and Howard County seeing a tripling of the number of applications. By July of 2020, Maryland acquired the most SNAP participants in the state's history—over 855,000 participants or 14% of the state's population (5). As of April 2022, there are 763,835 SNAP participants in Maryland (5).



In the summer of 2022, the Covid-19 pandemic is still having an impact on our state, our economy and our food system. SNAP, WIC, school meals and charitable efforts are still working to address food insecurity. Over the course of these two years, two important points have been learned. First, we have developed tools and policies that have helped millions of Marylanders. Second, and just as importantly, we have demonstrated that policy can address challenges. Given data and tools, policymakers can – and have – made a difference in the lives of our communities. We hope that this report provides information for prospective policymakers like you. The following profiles provide a snapshot of hunger, poverty, and federal program participation across the state of Maryland, including your community.



CACFP and SSO data from the 2021–2022 school year are based on daily averages of the number of breakfasts and lunches served on school days during the months from September 2021 through May 2022. SFSP data from summer 2021 include the months of June, July, and August 2021.

The number of meal sites for the child nutrition programs was pulled from October for data covering the 2021-2022 school year and from July for data covering summer 2021.

To determine average daily participation (ADP) for summer 2021 and the 2021-2022 SY, the ADP of each individual month was added together and divided by the number of months included in the time period being reported. ADP for CACFP is based off of supper meal count data.

Participation numbers are not included for the School Breakfast Program and National School Lunch Program for the 2021-2022 school year. Due to pandemic-related waivers all meals served by public school authorities in Maryland during this time were served through SSO.
